# The VSK University Regulations Governing the Rights, Powers & Functions of the Hostel Management 2020:-

# 1. Name of the Regulations:

These Regulations shall be called "The VSK University Regulations Governing the Rights, Powers & Functions of the Hostel Management 2020."

#### 2. Effective Date:-

They shall come into force on the date of the approval by the syndicate of the University.

# 3. Hostel Management:-

The Following officers of the university shall constitute the Hostel Management:

#### 4. Allotment of the Rooms:-

- 1. Students shall occupy the rooms allotted to them and shall not change/exchange rooms without prior permission from the Warden. Violations of this rule shall entail the expulsion of the student concerned from the hostel.
- II. Rooms are allotted to each student on his/ her personal responsibility. He/she should see to the upkeep of his / her room, hostel and its environment. Students should bring to the notice of the Engineering Department through the Warden, all routine maintenance works (Civil, Carpentry and Electrical), if any, to be carried out in their rooms.

# 5. Shuffling of inmates:

Inmates may be shifted from one room to another without assigning any reason by the Warden as per directions of the competent authority of the University.

# 6. Movement of Furniture barred & imposition of penalty in case of damage:-

Hostel Furniture shall not be removed from one room to another under any circumstances. Students are responsible to take care of furniture and fittings in their respective rooms. The cost of furniture and fittings shall be recovered from the concerned in case of any damage or loss along with the fine of Rs.1000/-. The student is required to fill in the inventory of the furniture and other items available in his/her room and hand over the same & other materials in good condition when he/she changes/vacates the room/hostel.

# 7. Extra electrical fittings not allowed:

Students are prohibited from using extra electrical fitting in their rooms. The use of electrical appliances such as immersion heaters, electric stove / heaters / electric iron are forbidden. Private cooking in the hostels / student's room is strictly forbidden. Such appliances, if found shall be confiscated and a fine shall also be imposed.

# 8. Penalty for disfiguring doors, glass panels Furniture & walls etc:

- I) All the rooms, doors, ventilators and windows should be kept neat and tidy. A fine of Rs.2000 shall be levied for disfiguring doors, glass panels, Furniture and walls from the occupants of the rooms in addition to the amount required for repairing and repainting the same
- II) A Collective fine of Rs.3000 /-shall be levied on occupants of the respective rooms/floors for disfiguring corridors and Bathrooms in addition to the amount needed for effecting requisite repairs.

III. A Collective fine of Rs.5000 /-shall be imposed from the residents of respective blocks for disfiguring the common rooms or damaging the public property of hostel blocks, in addition to the replacement cost.

8. Students shall keep the toilets and bathrooms clean failing which a collective fine of Rs.3000/- shall be charged from the residents of the respective rooms/floors.

# 9. Lights, Fans etc to be switched off when not in use:-

Residents are instructed to switch off the lights and fans and all the electrical / electronic appliances, when they go out of their rooms to save electric power and also the electricity consumption charges. A fine of Rs.250/- per day shall be collected from the occupants of the rooms, who violate this instruction.

### 10. Guests /Visitors are not permitted:-

Guests /Visitors are not permitted to enter any rooms allotted to the residents. Anyone who violates this rule shall be liable to pay a fine of Rs.1000/- and shall be ejected from the hostel by the management.

# 11. Functions, Meetings not allowed:-

Students shall not arrange any functions or meeting within the precincts of hostel and the University Campus

#### 12. Cessation of Hostel membership:-

A student who is expelled from the University shall cease to be a member of the hostel.

# 13. No Right to claim Accommodation:-

Accommodation in the hostel shall not be claimed as a matter of right.

### 14. Students to stay put in Hostel:

No student shall stay away from the hostel on any day without the prior permission of the concerned-Warden.

# 15. Pasting of posters /pictures etc. prohibited:-

Students shall not paste any posters /pictures/drawings/ Scribbling on the walls, doors, windows and shelves. Cut-outs shall not be placed or brought in the hostel.

# 16. Keeping of Valuables in Rooms Barred:

Student shall not keep large amount of cash or valuables like mobile phones, camera, Electronic gadgets, jewelry etc. in their rooms. Hence complaint about loss or theft of such items shall not be entertained.

# 17. Parking of Vehicles barred:

Students are not permitted to keep their Mopeds, Motor cycles, Scooters and cars in the hostel premises.

# 18. Students to be in rooms at designated time:

- I. Students shall settle in their rooms at 9 pm on normal days and at 10 pm on free night days (holidays and Sundays) & maintain absolute peace & tranquility.
- II. Students shall return to the hostel before 8 pm on all days.

# 19. Possession of Identity Cards Mandatory:

All residents are required to carry their valid Identity Cards issued to them by the university.

#### 20. Students to Vacate the Rooms for maintenance work:

The Students shall co-operate in carrying out maintenance work and vacate their rooms completely when the Hostel Management requires the same for this purpose.

# 21. Screening of pirated movies not allowed:-

The students shall not screen pirated / unauthorized / unlicensed movies in their computers and common rooms.

#### 22. Smoking and consumption of alcoholic drinks prohibited:

Smoking and consumption of alcoholic drinks and / or narcotic drugs in the hostel premises is strictly forbidden. Students shall not enter the hostel premises in intoxicated state and shall not possess such materials. Action shall be taken if any resident is found to violate this, which may result in his expulsion from hostel and rustication from the University. The University is a smoke-free zone under section 4 of The Cigarettes and Other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Act, 2003. Students shall not smoke inside the hostel / room / common room / dining hall / toilets / corridors / terrace etc. The management reserves the right to take disciplinary action, including expulsion at short notice from the hostel.

#### 23. Penalty & punishment for affray & ruckus:-

Any student who is found indulging in undesirable activities such as physical assault, affray, creating ruckus and inflict damage to the property of the University shall be liable to the following punishments:

- a) He / she will be expelled from the hostel.
- b) A record of his / her misconduct shall be incorporated in his/her personal file.
- c) The cost of damage shall be recovered in toto from him / her together with penalty.

d) He / she shall also be liable to be fined.

# 24. Harboring offender not permitted:-

Any student found hosting / harboring an offender shall be also liable to the punishments mentioned in Rule 24.

#### 25. Undesirable activities not allowed:-

Residents shall not participate in any anti-national, anti- social or undesirable activity in or outside the campus.

#### 26. **Visitors**:

All visitors to the hostel including the parents/guardians shall make necessary entries in the visitor's book available at the hostel entrance with the security personnel. The visit of men students to the women's hostel and vice- versa is restricted.

# 27. Use of audio system not permitted:-

The use of audio system which may cause inconvenience & nuisance to the occupants is not allowed. The use of personal TV, VCR and VCD / DVD is prohibited. Residents should not indulge in practices / activities, which may endanger their own personal safety as well as others.

#### 28. Personal responsibility for the safety of belongings:-

Residents shall be personally responsible for the safety of their belongings.

# 29. Undesirable activity to be reported:

Residents are duty bound to report to the Warden in case they notice any undesirable activity in the hostel premises.

#### 30. Unauthorized picnic/excursion/outings not allowed:-

Students shall not arrange for any picnic/excursion/outing save without the specific permission of the competent authority of the University.

#### 31. Duty to Safeguard environment:-

Residents are required to be conscious of the environment in which they live by keeping it clean, healthy and presentable. Students shall not throw litter indiscriminately and shall not use non-bio-degradable items, such as plastic carry bags and bottles.

#### 32. Food not to be wasted:-

No diner shall waste food. Paying mess bill does not entitle a diner to waste food.

# 33. Surroundings to be kept clean:-

The inmates shall cooperate in maintaining the mess and surroundings neat and clean. No notices shall be pasted on walls. Notices put up on the notice boards shall be not be removed by the diners.

#### 34. Politeness with mess staff:-

All diners shall interact with the mess staff in the dining hall in a courteous manner.

#### 35. Utensils to be kept in the designated bins.

After consuming food, diners shall leave the cup, plate, waste food etc. in the designated bins.

#### 36. Pet animals not allowed:-

Students shall not bring any pet animals into the mess hall or encourage such practice.

# 37. Action by the management in event of breach:

The Hostel management in event of breach of any of the rules enumerated hereinbefore shall be competent to conduct an enquiry against a delinquent student after adhering to the Principles of Natural Justice & Fair play. The Hostel Management shall initiate take disciplinary action after the receipt of the enquiry report. The management shall be entitled to order the expulsion

of the delinquent students if charges leveled against him are established in the course of a duly constituted enquiry.

# 38. Mess Food /utensils not to be taken outside:-

Students on no account whatsoever shall take food outside the mess. Nor can they take mess utensils such as plate, spoon, tumblers, etc, to their rooms.

# 39. Undertaking by Parents/Guardians & students:

The students Parents/Guardians shall execute an undertaking in the prescribed format (appended to these Rules) conceding to adhere to the rules in letter & also in spirit.

# 40. Saving Clause:-

The right to amend modify rescind annul vary or abrogate any or all of the rules is reserved.
