STATUTE GOVERNING THE ESTABLISHMENT AND FUNCTION OF SPECIAL CELL FOR SC/ST UNDER SECTION 40 (1) (p) OF THE KSU ACT, 2000

1. TITLE AND COMMENCEMENT :

- i) This Statute shall be called "Vijayanagara Sri Krishnadevaraya University Statute Governing the Establishment and Functions of Special Cell for SC/ST".
- ii) This Statute shall come into force from the date of assent by the Chancellor


2. ESTABLISHMENT :


- i) A Special Cell for SC/ST shall be established in the University.
- ii) It shall carry out the functions as enumerated under this Statute.

3. FUNCTIONS OF THE SPECIAL CELL :


- i) To circulate the decisions of the Government of India and the University Grants Commission and to collect regularly, on an annual basis, information regarding course-wise admission of candidates belonging to the Scheduled Castes and Scheduled Tribes in the University and Colleges for different courses in prescribed forms by a stipulated date, and to take follow up action, wherever required.
- ii) To circulate orders of the Government of India orders and the decisions of the University Grants Commission and collect information in respect of the appointment and training of candidates belonging to SC/ST in teaching and non-teaching posts in the University in suitable forms by a stipulated date and take follow up action, wherever required.
- iii) To collect reports and information regarding the Government of India orders on the various aspects of education, training and employment of Scheduled Cast and Scheduled Tribe candidates, for evolving new policies or modifying existing policy by the Commission.
- iv) To analyze information so collected under 3(i) to 3(iii) above and prepare reports and digests for onwards transmission to the Ministry of Human Resource Development / the University Grants Commission and such other authorities as may be required.
- v) To deal with representations received from Scheduled Castes and Scheduled Tribes candidates regarding their admission, recruitment, promotion and other similar matters incidental thereto.
- vi) To monitor the working of the Remedial Coaching Scheme in the University.
- vii) To function as a Grievances Redressal Cell for redressing the grievances of SC/ST students and employees of the University and render them necessary help in solving their academic as well as administrative problems.

- viii) To maintain a register for employment of SCs / STs in the University and colleges in respect of the candidates belonging to SC/ST for various posts in the University.
- ix) Any other work assigned from time to time to promote higher education among these two Communities suffering economic, social and educational deprivation.
- x) The SC/ST Cell will exclusively look after the work related to SC/ST. No other work shall be assigned to it.
- xi) An officer not below the rank of Deputy Registrar be incharge of the SC/ST Cell.


