### STATUTE - 13

TATUTE GOVERNING THE ESTABLISHMENT AND FUNCTIONS OF SPECIAL CELL FOR OTHER BACKWARD CLASSES (OBC) UNDER SECTION 41 (1) (p) OF THE KSU ACT, 2000. 1.TITLE AND COMMENCEMENT:

- This Statue shall be called "Vijayanagara Sri Krishnadevarya University Statue Governing the Establishment and Functions of Special Cell for OBCs."
- This status shall come in to force from the date of assent by the Chancellor

### 2. ESTABLISHMENT:

i) A Special Cell shall be established for OBC in the University consisting of the following members -

a. Vice-Chancellor

Chairman

b. Registrar

Member

c. Finance Officer

Member

d. One Syndicate member

Member (Nominated by the Vice-Chancellor)

e. One Academic Council member

Member (Nominated by the Vice-Chancellor)

f. Director of Students Welfare

Member

g. District Welfare Officer

Member

h. Deputy Registrar (Administration) Convener

ii) It shall carry out the functions as enumerated under this statue.

### 3. FUNCTIONS OF THE SPECIAL CELL:

To circulate the decisions of the Government of India and the University Grants Commission and to collect regularly, on an annual basis, information regarding course-wise admission of candidates belonging to OBC in the University and Colleges for different courses in prescribed forms by a stipulated date, and to take follow up action, wherever required.

To circulate orders of the Government of India orders and the decisions of the ii) University Grants Commission and collect information in respect of the appointment and training of candidates belonging to OBC in teaching and nonteaching posts in the University in suitable forms by a stipulated date and take follow up action, wherever required.

To collect reports and information regarding the Government of India orders on iii) the various aspects of education, training and employment of OBC candidates, for evolving new policies or modifying existing policy by the Commission.

To analyze information so collected under 3(i) to 3(iii) above and prepare iv) reports and digests for onwards transmission to the Ministry of Human Resource Development / the University Grants Commission and such other authorities as my be required.

To deal with representation received from other Backward Classes candidate iii) regarding their admission, recruitment, promotion and other similar matters in the University.
