GRADUATE GOVERNING THE GUIDELINES FOR PERMITTING POST GRADUATE DEGREE PROGRAMMES IN CONSTITUENT COLLEGES / AFFILIATED COLLEGES OF VIJAYANAGARA SRI KRISHNADEVARAYA UNIVERSITY, BELLARY. FRAMED UNDER SEC. 40 (g) READ WITH SEC. 59 OF THE KSU ACT 2000.

#### 1. TITLE AND COMMENCEMENT

- This statute shall be called "Statute governing the guidelines for permitting Post-Graduate Degree Programmes in affiliated colleges".
- ii) It shall come into effect from the date of assent by the Chancellor.

#### 2. GENERAL CONDITIONS

- a. A College which seeks permission to start post-graduate programmes shall comply with the provisions of the Act, Statutes, Ordinances, Rules and Regulations of Vijayanagara Sri Krishnadevaraya University, Bellary framed in that behalf.
- b. All colleges which have permanent affiliation or minimum of five years of continuous affiliation and possessed of NACC accreditation shall be eligible to Commence P.G. programmes.
- c. There shall be a separate faculty for each P.G. programme. The U.G. teachers with doctoral qualification may also handle P.G. classes.
- d. There shall be a core faculty consisting of at least four full-time members for each PG. programme. All faculty members shall possess the qualification prescribed by the UGC for the respective discipline from time to time and among them at least two members shall possess Doctoral Qualifications.
- e. All faculty members shall be paid salary as per pay scales and allowances prescribed by UGC/AICTE/University from time to time for the concerned cadre viz., Professor/Reader/Lecturer and payment shall be made by means of a crossed cheque.
- f. The conditions governing the service of the staff shall be in accordance with the Statutes/ Ordinances/Rules of the University prescribed for Private Colleges.
- g. In addition to the core Faculty, retired teachers having more than five years of teaching experience at the PG level may be employed as visiting faculty to teach certain specialized topics/subjects. In this

VICE CHANCEL OR Vijayanagara Sri Krishnad Waraya University Vijayanagara Sagar Campus, Vinayakanagar, behalf the services of eminent persons may be enlisted, if required in exceptional circumstances.

- h. At least one full time P.G. faculty member of the college and one representative of the University shall be represented in the Governing Council of the College.
- i. The students shall be admitted to the post-graduate programmes as per the regulations prescribed for the concerned programme by the University and by adhering to the guidelines for admissions issued by the State Government from time to time.
- j. A rational and transparent fee structure shall be adopted by the Institution. The institution shall not charge capitation fee. An appropriate machinery set up by the State/University will ensure that no capitation fee is charged and that there is no profiteering though a reasonable surplus for the furtherance of education is permissible.
- k. The college shall pay special attention to the welfare of Backward Classes and Scheduled Castes/Tribes and for this purpose follow the guidelines, directions and notifications issued by the State Government from time to time.
- 1. No college shall impose any levies on its teaching and non-teaching staff for meeting recurring or non-recurring general or special expenditure.

### 3. INFRASTRUCTURE

- a) The college shall be in lawful possession of adequate land for creating necessary infrastructure. It shall submit a blue print of the building proposed for the PG programme, duly approved by the concerned local authorities.
- b) The college shall have a separate Library for the P.G. programmes. The Library shall have facilities like reading room, journal section, text book section and reference section along with internet facility. The seating capacity shall be in accordance with the strength of the P.G. students. A

- A separate full time Librarian shall be appointed for the P.G. Library, if more than two P.G. programmes were to be permitted in a college.
- c) There shall be separate classrooms, staff rooms, ladies common room and laboratories (wherever necessary) for the P.G. programmes. The size of the classrooms, laboratories etc., shall be in accordance with the intake fixed for each programme and for this purpose guidelines of the University issued from time to time shall be followed.
- d) There shall be separate hostel facility for P.G. Students.
- e) The college shall satisfy the University that adequate financial provision has been made for managing the college and the college has deposited the funds collected for this purpose in a nationalized bank.
- f) The college shall also satisfy the University that it has adequate recurring income from its own resources for its continued and efficient functioning.

#### 4. RESEARCH FACILITIES

- a. The college shall provide separate research facilities relevant to the concerned P.G. Programme as noted below:-
  - Library: The Library shall have adequate number of books and journals (both Indian & Foreign) in the concerned discipline.
  - Data-base relating to the concerned discipline.
  - Laboratory: A research laboratory exclusively for the purpose of conducting research.

## 5. RECORDS, ACCOUNTS AND AUDIT

a. In the case of a private college the accounts shall be audited at the end of each financial year by a chartered accountant. A copy of the annual accounts and the audit report of the college shall be made available to the University and the State Govt.

b. All the registers and records which are required to be maintained as per the University Regulations Govt. Orders shall be maintained and be made available for inspection by the University/Government whenever required.

### 6. PRELIMINARY PROJECT REPORT

A college which intends to apply for P.G. Programmes shall prepare a preliminary project report showing the infrastructure and facilities available for each programme and sufficient proof of financial and other resources for sustaining the programmes. It shall also give an undertaking to abide by all the conditions mentioned above if it is to be considered for grant of affiliation to P.G. programmes. After receipt of the preliminary project report, the University shall constitute a Screening Committee consisting of the Dean of the concerned faculty and one or two experts as members to be nominated by the Vice-Chancellor to evaluate the report and give its opinion as to the feasibility and need for taking such starting the P.G. programmes in the college. The report of the screening committee shall be placed before the Syndicate for its consideration and for such further action as may be feasible.

## LOCAL INQUIRY COMMITTEE REPORT

A college shall apply for affiliation to the P.G. programmes in the proforma prescribed for the purpose and shall enclose all documents relevant thereto and adhere to all the conditions mentioned in section 59 (3) of the KSU Act 2000.

The Syndicate after considering the application shall direct a local enquiry by LIC. The LIC shall strictly follow the said guidelines and shall not recommend for affiliation if the institution is not capable of fulfilling the conditions prescribed for managing the P.G. programmes.

## 8. FINAL APPROVAL

C.

The report of the LIC shall be placed before the Academic Council and the Syndicate as per the provisions of the Act and the application along with the proceedings of Academic Council and Syndicate shall be submitted to the Government for final approval.

When a Post-Graduate programme is permitted in a College, 50% of the intake sanctioned to the programme or such percentage as fixed by the State government from time to time shall be set apart for admission of candidates by the University.
