## CTITLE AND COMMENCEMENT

i) THIS STATUTE SHALL BE CALLED "VIJAYNAGARA SRI KRISHNADEVARAYA UNIVERSITY STATUTE GOVERNING ESTATE ADVISORY BOARD FRAMED UNDER SECTION 37(1) of the KSU ACT, 2000."

ii) THIS STATUTE SHALL COME INTO FORCE FROM THE DATE OF

THE ASSENT BY THE CHANCELLOR

### . CONSTITUTION

The Estate Board shall consist of: -

i) The Vice-Chancellor who shall be the Ex-Officio Chairperson

ii) The Registrar (Admn) Vijaynagara Sri Krishnadevaraya University, Bellary

iii) The Chief Engineer or his nominee C & B. Bangalore

iv) The Executive Engineer (Elect) O & M Division, KPTCL (Ex-Officio) Bellary.

v) One Syndicate member and one member of the Academic Council nominated by the Vice-Chancellor.

vi) The Finance Officer, Vijaynagara Sri Krishanadevarya University, Bellary (Ex-Officio)

vii) The Commissioner, City Corporation, Bellary (Ex-officio)

viii) The Joint Director of Land Records Belgaum Division, Belgaum (Ex-Officio)

- ix) The Resident Engineer, Vijaynagara Sri Krishanadevarya University, Bellary (Member Secretary) (Ex-Officio).
- 3. The Members of the Board nominated by the Vice-Chancellor shall hold the office for a period of two years or so long as they continue to be the members of the Syndicate whichever is earlier. Any casual vacancy may be filled for the residuary period of his/her predecessor.
- 4. The Board shall meet at least four times in a year before the Annual Convocation and at other times when convened by the Vice-Chancellor. The Vice-Chancellor shall preside at all the meetings of the Board and in his absence the members shall elect the Chairman. Four members shall constitute the quorum.

### 5. POWERS AND FUNCTIONS

- 5.1 The Board shall be in charge of the University estate and shall recommend to the Syndicate any repairs alterations or additions and shall advise the Syndicate in all the matters relating to the University Estates.
- 5.2 (i) It shall scrutinize plans, estimates tenders and such other documents connected with construction, repair and renovation of buildings and other structures in the University.

(ii) It shall supervise, monitor and execute the works approved by the Syndicate with regard to the works enumerated in clause (i) above.
