1. TITLE AND COMMENCEMENT


- i) THIS STATUTE SHALL BE CALLED VIJAYANAGARA SRI KRISHNADEVARAYA UNIVERSITY STATUTE GOVERNING STUDENTS' WELFARE ADVISORY BOARD AS PER SECTION 37 OF KARNATAKA STATE UNIVERSITIES ACT 2000.
- ii) THIS STATUTE SHALL COME INTO FORCE FROM THE DATE OF THE ASSENT BY THE CHANCELLOR


2. STUDENTS' WELFARE ADVISORY BOARD COMPOSITION

2.1 The Board of Students Welfare shall consist of -

- i) The Vice-Chancellor (Ex-Officio Chairperson)
- ii) The Registrar (Ex-Officio)
- iii) The Director of Physical Education Vijayanagara Sri Krishnadevaraya University, Bellary.
- iv) The Chief Medical Officer, Vijayanagara Sri Krishnadevaraya University, Bellary (Ex-Officio)
- v) Two Members of the Syndicate, one of whom shall be a Lady Member nominated by the Vice-Chancellor.
- vi) N.S.S. Co-ordinator, Vijayanagara Sri Krishnadevaraya University, Bellary.
- vii) Two Members of the Academic Council nominated by the Vice-Chancellor.
- viii) The Director, Students' Welfare, Vijayanagara Sri Krishnadevaraya University, Bellary Ex-Officio Member Secretary.
- ix) The Chairperson may nominate two experts for a meeting whenever so required.
- x) Two P.G. Students (One male and One female Student) nominated by the Vice-Chancellor, as per the recommendation made by the President, P.G. Gymkhana from among the secretaries be included yearly for a period of one year.

2.2 Members of the Board other than ex-officio members shall hold office for a period of two years. Any casual vacancy shall be filled for residuary period of his/her predecessor.

2.3 The Board shall meet at least twice in an academic year and at other times when convened by the Chairman. A minimum of four members shall constitute the quorum.

### 3. POWERS AND FUNCTIONS

3.1 The functions of the Students Welfare Advisory Board shall be to advise the Syndicate on :-

- i) Providing Medical and other required facilities to the students.
- ii) Arranging Sports activities of the students.
- iii) Monitoring hygiene and diet of college canteens and students Hostels.
- iv) Monitoring Welfare activities of the students of the University and Constituent Colleges and other Affiliated Colleges.


2 Organizing activities for the overall personality development of the students mainly focusing on skills development to enhance their employability.

3 Organizing of the NSS activities of the students of the University and Colleges.


