STATUTE RELATING TO THE APPOINTMENT AND FUNCTION OF THE FINANCE OFFICER UNDER SECTION 19(1) AND (2) OF THE KARNATAKA STATE UNIVERSITIES ACT, 2000.

1. TITLE AND COMMENCEMENT

- i) This statute shall be called "Vijayanagara Sri Krishnadevaraya University Statute relating to the Appointment, Powers and Functions of The Finance Officer.
- ii) This statute shall come into force from the date of assent by the Chancellor.

2. APPOINTMENT OF THE FINANCE OFFICER

The appointment of the Finance Officer shall be made in accordance with the provisions under sections 19(1&2) and 20 of the KSU Act, 2000.

"19(1) - The Finance Officer shall be a whole - time officer of the University appointed by the Vice-Chancellor with the approval of the Syndicate from out of a panel of not less than three persons being officers in the cadre of Joint-Controller of State Accounts Department or an Officer of the Rank of Deputy Accountant-General having experience in audit, accounting and financial administration, recommended by the Vice-Chancellor to the Syndicate. If none in the panel is approved by the syndicate within the time prescribed by the statutes, the Chancellor may, in consultation with the Vice-Chancellor, appoint such other person as he deems fit to be the Finance Officer".

"19(2) - The tenure of appointment and the emolument of the Finance Officer and other terms and conditions shall be as determined by the Chancellor".

"20(2) - In the event of death, suspension or temporary absence of the Finance Officer, the Chancellor may authorize any other suitable officer of the University to perform the duties of the Finance Officer".

"20(2) - pending appointment of a suitable officer to fill the vacancy in the office of the Finance Officer, the Vice-Chancellor may, in his discretion, authorize any officer to perform the duties of such vacant post till the appointment is made. The Vice-Chancellor shall immediately report the action taken by him under the sub-section to the Chancellor".


3. FUNCTIONS OF THE FINANCE OFFICER

The Finance officer shall

- i) Maintain proper accounts of the receipts and expenditure of the University.
- ii) Prepare under the direction of the Syndicate a statement of accounts of the University which would be placed before the Finance Committee, the Syndicate and the Academic council before being submitted to the Government.
- iii) Submit the accounts for audit and make available to the auditors all necessary information and records.
- iv) Assist the Syndicate to prepare the financial estimates for the ensuing financial year for being placed before the Finance Committee, Syndicate & Academic Council before the end of March.





- v) Give his opinion on such financial matters when refer to him by the Vice-Chancellor /Registrar and such opinion shall be placed before the Syndicate.
- vi) Under the directions of the Vice-Chancellor, call for meetings of the Finance Committee.
- vii) The Finance Officer shall operate the funds of the University, subject to the provisions of section 19(3) of KSU Act, 2000. In the absence of the Finance Officer, the Vice-Chancellor may nominate any other officer not below the rank of the Deputy Finance Officer/Deputy Registrar of the University to perform his functions.
- viii) The Finance Officer shall be the head of the Finance Department of the University and shall supervise and control the staff under him.
- ix) It shall be competent for the Finance Officer to place before the Syndicate any proposals for improvement of the financial position of the University or for effecting savings in respect of any items of expenditure.
- x) He shall be ex-officio member of the Academic Council and the ex-officio member-secretary of the Finance committee.
- xi) He shall also, subject to the control of the Finance Committee, exercise such other powers and perform such other functions as may be prescribed by the Ordinances and the Regulations or as may be prescribed from time to time by the Vice-Chancellor or the Registrar.






