STATUTE GOVERNING THE APPOINTMENT, POWERS AND FUNCTIONS OF THE DEANS OF THE FACULTIES UNDER SECTION 21(1) AND 21(3) OF KSU ACT, 2000.

TITLE AND COMMENCEMENT 1.

- This statute shall be called "Vijayanagara Sri Krishnadevaraya University Statute i) relating to the Appointment, Powers and Functions of The Deans of the Faculties".
- This statute shall come into force from the date of assent by the Chancellor. ii)

2. APPOINTMENT OF DEAN

A Professor in each Faculty according to seniority by rotation shall act as Dean of the Faculty for a period of two years.

Provided that if there is no Professor, the senior-most Associate Professor shall act as Dean.

Provided further that if in any Faculty there is no professor or Associate Professor, the Vice-Chancellor may, in his discretion, designate any other suitable Teacher to act as Dean.

Provided also that where no person is available in a Faculty to act as Dean of the Faculty or where the University does not have such a Department of Studies for any Faculty, such teacher in a Department of Studies in any affiliated college may be nominated by the Vice-Chancellor on the basis of seniority to act as the Dean of the Faculty.

3. POWERS OF THE DEAN

- The Dean shall be the Executive Officer of the respective Faculty and shall preside i) over the meetings of the Faculty.
- The Dean shall be in overall charge of the academic program in the Faculty which ii) shall include teaching and research.

4 FUNCTIONS OF THE DEAN

- To furnish opinion on academic matters in consultation with the concerned i) Chairman of the Board of Studies when referred to by the Vice-Chancellor /Registrar/other authorities of the University.
- To present the eligible candidates for award of degrees at the Convocations. ii)
- To carry out such other academic assignments as may be entrusted by the Viceiii) Chancellor.
- To carry out such other functions and duties that may be prescribed in any iv) Statutes or Ordinances or Regulations for the time being in force.

SENIORMOST DEAN FOR THE PURPOSE OF SECTION 16 OF KSU ACT 5.

Only a professor who has functioned as Dean for the longest period shall be considered as Senior Most Dean for the purpose seniority Under Section 16 of KSU Act.
