TATUTES RELATING TO RULES OF BUSINESS OF THE BOARDS OF STUDIES UNDER SECTION (33) OF KSU ACT, 2000.

TITLE AND COMMENCEMENT

This statute shall be called "Vijayanagara Sri Krishnadevaraya University Statute relating to the Rules of Business of the Boards of Studies".

- ii) This statute shall come into force from the date of assent by the Chancellor.

2. CONSTITUTION OF THE BOARD

Every Post-Graduate and Under-Graduate Board of Studies shall be constituted by the Syndicate for a term of three years, out of the panel of names recommended by the Chairpersons of Boards of Studies in office. Such panel of names shall comprise:

- i) Internal persons: The names of faculty (teachers) working in the University and affiliated colleges of the Vijayanagara Sri Krishnadevaraya University;
- ii) External person; The names of senior faculty (teachers) working in other Universities; and
- iii) The names of outstanding persons in the related fields.

3. COMPOSITION OF THE BOARDS OF STUDIES

- i) The members of each Board of Studies shall be appointed by the Vice-Chancellor in consultation with the Syndicate, from among the teachers of the University and the teachers of affiliated/constituent colleges of the University; Provided that for the Post-Graduate Board of studies there shall be at least two external members and at least two other members in the related field.

Explanation

- i) "External member" means a member who is not a teacher of this "University or a College/Institution affiliated to it.
 - ii) "Related field" means the field having close connection with the subject(s) for which the Board of Studies has been set up. The objective is to encourage inter-disciplinary approach.
2. Any other person possessing special knowledge of the subject concerned can also be nominated as a member or invited by the Vice-Chancellor to participate in the deliberations of the Board.


3. CHAIRMAN OF THE BOARD

The Chairman of a Post Graduate Board of studies shall be nominated by the Vice-Chancellor and such Chairperson shall be ex-officio Chairperson of the Under Graduate Board of Studies for the same subject or group of subjects.

CESSATION OF MEMBERSHIP

A member nominated in his capacity as a teacher in any other University or its affiliated college or as the holder of an office shall cease to be a member of the Board of studies concerned from the date he ceases to be a teacher in the University or of such College or the holder of any such office. Any person appointed in a casual vacancy shall, subject to other provisions, be a member of the concerned Board of Studies only for the residual period for which the person in whose place he is nominated.

5. STRENGTH OF THE BOARD

No Board of Studies shall consist of less than five or more than twelve members; provided, however, that the Under Graduate Board of Studies shall consist of not more than six members including the Chairperson. If a subject is not taught in more than two colleges, there shall be only one Board of Studies i.e., the Post Graduate Board to which at least one member from the Under Graduate college shall be nominated.

6. AMALGAMATION

The Syndicate may, at its discretion, amalgamate the Under Graduate Board of Studies and the Post Graduate Board of Studies relating to the same subject and also constitute combined Boards of Studies for one or more subjects enumerated in the Ordinance for the sake of co-ordination and maintenance of standards.

7. QUORUM

The quorum for a meeting of any Board of studies shall not be less than half the strength of the Board.

8. ARRANGEMENT DURING THE ABSENCE OF THE CHAIRPERSON

When the Chairperson of a Board of studies is unable to carry on his functions temporarily, the Vice-Chancellor may appoint any other member of the Board to act on his behalf during such a period.

9. FUNCTIONS OF THE BOARD

- i) The Board of studies shall consider a report on any matter or an issue referred to it by the Syndicate or the Dean of the concerned Faculty.
- ii) The Board of studies of a subject or a group of subjects shall recommend to the Academic Council through the concerned faculty, the detailed courses of study and curricula for the different levels of studies in such subject(s).
- iii) The Post Graduate Board of Studies shall perform all the functions assigned to it under the Ph.D Regulations.

10. POWERS OF THE BOARD

The Board of studies shall have power....

- a) to prepare and recommend to the Academic Council, the schemes of Examinations, through the concerned Faculty;
- b) to recommend the text books for the several courses of study;
- c) to advise the authorities of the University on such matters as may be referred to it.
- d) to prepare and approve the panel of examiners.

MEETINGS

The Board of Studies shall normally meet once a year and make several academic recommendations. The special meetings of the Boards of Studies may be convened, under extraordinary circumstances, under the directions of the Vice Chancellor. The Registrar, under the directions of the Vice-Chancellor, shall fix the date and time of the meetings of the Boards of studies and all the Boards shall meet on the appointed date and time.

- ii) On the requisition/circular received from the Registrar, the Chairperson of the Board of studies shall issue the notice of meeting along with the agenda at least ten clear days before the date of the meeting.
- iii) The chairperson of the Board of Studies shall preside over the meetings. In the temporary absence of the chairperson, the senior most internal member of the Board of Studies shall preside over the meeting.

12. JOINT MEETING OF BOARDS OF STUDIES

Under certain extraordinary circumstances, the Vice-Chancellor shall be competent to convene the joint meetings of two or more Boards of Studies and in all such meetings, the Vice-Chancellor shall preside.

13. MINUTES

All resolutions of the Board of Studies passed shall be recorded at the meeting and read out by the Chairperson for the information of the members present at the meeting.

The Chairperson of the meeting shall send to the Registrar a copy of the minutes within ten days after the date of the meeting.

The Vice-Chancellor may, in case of urgency, obtain the opinion of the Members of the Boards of Studies by circulation. Such opinion, together with the action taken thereon, shall be communicated to all the members.








