STATUTE RELATING TO THE CONFERRING OF DEGREES AT THE CONVOCATION
enacted under section-40(1)(d) and Section 69 read with Section 29(2)(t) of Karnataka
the Universities Act, 2000)

TITLE AND COMMENCEMENT

(1) This statute shall be called the Statute relating to the Conferment of Degrees at
Convocation.

(2) This Statute shall come into force from the date of assent of the Chancellor.

ANNUAL CONVOCATION

The Annual Convocation for the purpose of conferring Degrees shall ordinarily be
held once a year, preferably during the last month of the calendar year, on a date to be
fixed by the Syndicate and approved by the Chancellor. After so fixing the date of the
convocation, the Registrar shall issue a Notification containing all the particulars, at least
15 days prior to the date of the Convocation. Such notification shall, besides being put up
in the Notice Board of the University Office, shall be published in two leading
newspapers, one in Kannada and one in English, approved by the Vice-Chancellor.

SPECIAL CONVOCATION

i) Special Convocation may be held on such date and time as proposed by the
Syndicate and approved by the Chancellor, for conferring Honorary Degrees (Honoris
Causa).

ii) The procedure outlined in this Statute relating to the Annual convocation shall
apply mutatis mutandis in the case of conferment of Honorary Degrees also. However,
the recipients of the Honorary Degree may be allowed to make a brief address after
receiving such Degree and he/she shall be a member of the Convocation.

4. CANDIDATES ELIGIBLE FOR CONFERMENT OF DEGREES

The Registrar (Evaluation) shall prepare the course wise and Faculty wise lists of
eligible candidates, soon after the announcement of results, for the conferment of
degrees at the annual Convocation.

Provided that the names of eligible candidates, if missing due to any administrative
lapse or omission, shall be included, even after the Convocation, with the specific
approval of the Vice-Chancellor, which shall immediately be reported to the competent
Bodies, for necessary ratification.

5. HONORARY DEGREES

(1) If not less than two thirds of the Members of the syndicate recommend that an
Honorary Degree or academic distinction be conferred on any person, the syndicate may
recommend the same to the Chancellor. Such a person chosen by the Syndicate shall be
of eminent attainment and position, fit and proper to receive such a degree or academic
distinction. The Honorary Degree or distinction may be conferred only in exceptional
cases. Only such of the persons who have contributed substantially to the development
of Literature, Philosophy, Arts, Music, painting or any other subject pertaining to the
faculty of Arts, Science or Technology or conspicuous service rendered by them for the
cause of education shall be identified for the purpose of grant of Hon. Degrees.

A degree of Doctor of Science (D.Sc.) Honoris Causa may be conferred on persons in the branches of Science or Technology, planning Organizing or Developing Scientific and Technological Institutions.

A degree of Doctor of Laws (LL.D) Honoris Causa shall be conferred on persons who are distinguished Lawyers, judges or jurists, Statesmen or have made noteworthy contribution for the cause of the public.

Doctor of Literature(D.Litt.) and Doctor of Education (D.ED) Honoris Causa shall be conferred on eminent academicians or those persons who have rendered exceptionally outstanding social service.

The recipient need not submit any application for receiving the said Degree, or submit any declaration whatsoever.

The recommendation of the Syndicate for conferring Honorary Degree(s) on any person (s) shall be sent to the Chancellor for approval. The Honorary Degrees shall be conferred either at the Annual or Special Convocation and may be received by such person(s) either in person or in absentia.

The presentation of persons on whom honorary degrees are to be conferred shall be made by the Vice Chancellor.

The Honorary Degree Certificate (Diploma) shall be signed by both the Chancellor (or Pro-Chancellor, whenever he presides over the Convocation) and the Vice-Chancellor.

6. APPLICATION FOR DEGREE CERTIFICATE

All eligible candidates whose names are included or ought to have been included in the list of candidates found eligible for the conferment of Degree in the Annual convocation of that year, shall send their applications in the prescribed forms to the Registrar (Evaluation) so as to reach his office on or before the date and time fixed, which shall be not later than 30 days before the date set for the Convocation, along with the challan for having paid the fee prescribed, from time to time.


7. DECLARATION BY THE CANDIDATE


(i) Every candidate applying for the issue of a Degree certificate shall furnish a declaration duly signed by him/ her, to the following effect:

(a) "I hereby solemnly declare and promise the University that, if I were admitted to the Degree of For which I have been recommended, I shall conduct myself in my daily life and conversation, befitting a member of this University, that I shall, to the utmost of my capacity and opportunity, support the cause of morality and sound learning and that, as far as in me lies, I shall uphold and advance the social order and well being of my fellowmen.

(b) If it is subsequently established that I have obtained my Degree fraudulently or if it is established that I had obtained admission in the Institution last studied by me through a false caste/Income Certificate, I declare that the University may withdraw the Degree conferred on me, under section 70(1) of the Karnataka State Universities' Act, 2000.

(ii) In the case of those candidates on whom professional Degrees are being conferred, the following shall be added to the above declaration.

"I shall discharge my duties sincerely and faithfully in my profession held by virtue of my Degree; that I shall, on all occasions, maintain its purity and reputation and I shall never deviate from the straight path of this honorable exercise and I shall never make my knowledge subservient to unworthy ends."

8. ISSUANCE OF DEGREE CERTIFICATE

(i) The Medalists, Prize-winners, recipients of Ph.D. and other such distinctions and post-graduates can receive their Degrees either in person or in absentia. All other candidates shall receive their Degrees only in Absentia, and their certificates will be sent, by post, soon after the Convocation is held.

(ii) Provided that, if any eligible candidate, whose name has been included in the list of candidates eligible for conferment of Degree in the Annual convocation of that year, applies for issue of such Degree before the holding of such Convocation, the Vice-Chancellor, may order issue of such Degree to the candidate even before the Convocation subject to the condition mentioned below and shall report the same to the Academic council and Syndicate at their next meetings.

Condition (1) The application filed by such candidates shall disclose the immediate necessity for issuing such certificate either for the purpose of admission to higher education or for employment.

Condition (2): An affidavit mentioning the need for immediate issue of such Degree is to be enclosed along with the application; and

Condition (3): A special fee as prescribed is to be paid in addition to the regular fee prescribed for obtaining the Degree.

10. PRELIMINARY MEETINGS OF THE ACADEMIC COUNCIL AND SYNDICATE

There shall be a meeting of the Academic Council preliminary to the convocation, to consider and approve the List of eligible candidates proposed for conferring Degrees at the Convocation.

The Deans of Faculties shall present the list of eligible candidates in the Faculties, at the meeting. The most senior member of the Faculty shall present the list in the absence of the Dean. The Syndicate shall meet immediately after the meeting of the Academic Council to consider and approve the list of Candidates proposed for conferring Degrees.


11. DRESS CODE FOR THE CANDIDATES


Such of the candidates who intend to attend the Convocation and receive the Degrees in person, shall wear white dress. They shall occupy their respective seats in the auditorium well in advance before the commencement of the convocation.

12. ACADEMIC ROBES PRESCRIBED

(i) FOR THE MEMBERS OF THE SYNDICATE AND THE ACADEMIC COUNCIL:

(vii) For Chief Guest who delivers convocation address Cream Silk Gown with Gold Facings (Zari Border) with Sky Blue Shawl.

13. HEAD GEAR:

For Chancellor, Pro-Chancellor, Vice-Chancellor, Registrar, Registrar (Eva), Chief Guest and Recipients of Honoris Causa Degrees, there shall be Krishnadevaraya peta as head gears.

14. PROCESSION:

After donning the robes, the chancellor, the Pro-chancellor, the Vice-Chancellor and the Members of the Syndicate and the Academic Council shall pass in procession to the auditorium where the Convocation is to be held. The order of the procession is as follows

- (ii) Deans of Faculties (in pairs)
- (iii) Registrar(Evaluation)
- (iv) Registrar
- (v) Recipients of Hon. Degree (if any)
- (vi) Chief Guest
- (vii) Vice-Chancellor
- (viii) Pro-chancellor
- (ix) Mace-Bearer
- (x) Chancellor
- (xi) ADC

Candidates and others present in the Auditorium Shall remain standing till the dignitaries and members forming the procession resume their seats on the dais.

15. INVOCATION

After all the dignitaries and members of the Syndicate and the Academic Council have taken their seats, the Nadageethe shall be sung.

16. TO DECLARE OPEN THE CONVOCATION

After the invocation, the Vice-Chancellor shall welcome the gathering and request the Chancellor (or the Pro-chancellor, in the absence of the Chancellor) to declare the Convocation open, with the following words:

"Mr. Chancellor /Honorable Pro-Chancellor, I have the honor to request you to declare the Convocation open".

The Chancellor (or the Pro-Chancellor, in the absence of the Chancellor), will then declare the Convocation open and will say;

"This Convocation of the Vijayanagara Sri Krishnadevaraya University has been called to confer Degree upon the candidates who have been successful in the examination held for the purpose (and Honoris Causa wherever applicable) and who have been certified to be worthy of receiving the degrees. Let the candidates be presented".

17. PRESENTATION OF CANDIDATES

1.(a)The Vice-Chancellor shall present the recipient of Hon. Cause Degree to the Chancellor, with a citation.

(b) The recipient of the Honorary Degree will be awarded the Diploma by the Chancellor.

(c)The recipient of the Hon. Cause may make a brief acceptance Speech.

The Dean of the Faculty concerned shall present the candidates of the respective Faculties,

course wise, for the award of Degrees, Medals and Prizes, in the following words.

Sir/


I present the candidates whose names are set out in the list for the degree of -----

under the Faculty of _____. They have been Examined and found qualified for the respective Degrees to which they may be Admitted.

The candidates of all the Degrees in that Faculty shall get up from their seats, bow to the Chancellor and resume their seats. All the Deans shall present their candidates in the above manner, in the pre-determined order, in the order mentioned under Sec.34 of the KSU Act, 2000.

18. ADMISSION OF CANDIDATES FOR THE DEGREES / DEPLOMAS

After the presentation of all the candidates, the Chancellor shall accept all the candidates for various Degrees and shall make the following declaration.

"By virtue of the authority vested in me as Chancellor of the Vijayanagara Sri Krishnadevaraya University I confer the degrees of Honorius Causa and other degrees (The Degrees should be separately spelt). In token of this, all the candidates have been presented with Diplomas".

Acceptance speech by Honrary Causa Recipient.

The Vice-chancellor will then request the Honrary Causa to deliver his acceptance speech.

19. CONVOCATION ADDRESS

The Vice-chancellor introduces the Chief Guest and then request the Chief Guest to deliver the Convocation Address.

20. DISSOLUTION OF THE CONVOCATION

After the address by the Chief Guest, the Chancellor shall dissolve the Convocation by saying "I dissolve the Convocation". The Chancellor, the pro-Chancellor, the Vice-Chancellor, the Member of the Syndicate and the Academic Council shall exit in a procession, in the reverse order, as detailed below;

- (i) Mace-Bearer;
- (ii) Chancellor(followed by Aide-de-camp)
- (iii) Pro-Chancellor
- (iv) Vice-Chancellor
- (v) Chief Guest
- (vi) Recipients of Hon. Degrees (if any)
- (vii) Registrar
- (viii) Registrar (Evaluation)
- (ix) Deans of Faculties (in pairs)
- (x) Members of the Syndicate and the Academic Council (in pairs)

(i) The procedure outlined in this statute relating to the Annual Convocation shall apply mutatis mutandis in the case of conferment of Honorary Degree also except for the absence of recommendations of the Deans of the faculties.

21. POWERS OF VICE-CHANCELLOR TO MAKE SUITABLE CHANGES

The Vice-chancellor may effect suitable changes, with the prior approval of the Chancellor, regarding the procedure to be followed at the convocation when circumstances necessitate.




